That in consideration of **ONE HUNDRED SEVENTY TWO THOUSAND NINE HUNDRED AND NO/100-----DOLLARS (\$172,900.00)**, to the undersigned grantor, **LARRY KENT d/b/a LARRY KENT BUILDING CO.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of which is hereby acknowledged, the said **GRANTOR** does by these presents, grant, bargain sell and convey unto **RALPH BRADFORD GARRARD and wife, MEREDITH SIMS GARRARD** (herein referred to as **GRANTEES**), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, described as follows:


\$ 172,900.00 of the above recited purchase price was paid by a mortgage recorded simultaneously herewith.


