MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is entered into on this 7th day of April, 2004 by and between Sprint Spectrum L.P., a Delaware limited partnership, with an office at Sprint Sites USA, 6120 Powers Ferry Rd., 2nd Floor, Mailstop GAATLV0204-2067, Atlanta, GA 30339-2923 (hereinafter referred to as "Licensor") and Nextel South Corp., d/b/a Nextel Communications with an office at 6575 The Corners Pkwy, Norcross, GA 30092 (hereinafter referred to as "Licensee").

1. Licensor and Licensee entered into a Site License Agreement ("Agreement") on the 7th day of April, 2004 for purpose of installing, operating and maintaining a radio communications facility and other improvements. All of the foregoing are set forth in the Agreement.
2. The term of the Agreement is for five (5) years commencing on May 4, 2004, and ending May 3, 2009, with three (3) successive five (5) year options to renew. If all options to renew are exercised, the term of this Agreement will expire twenty (20) years after the Commencement Date (as defined in the Agreement).
3. The Land which is the subject of this Agreement is described in Exhibit A annexed hereto. That portion of the Land being leased to Licensee ("Premises") is described in Exhibit B annexed hereto.

A parcel of land situated in the Northwest Quarter of the Northeast Quarter of Section 18, Township 18 South, Range 1 East, Shelby County, Alabama, and being more particularly described as follows:

Commence at the Northwest Corner of the Northwest Quarter of the Northeast Quarter of Section 18, Township 18 South, Range 1 East, thence with the north line of said quarter quarter section run North 89°52'17" East for a distance of 348.80 feet to a point; thence run South 00°07'43" East for a distance of 101.97 feet to a point, said point being the Point of Beginning; thence run North 90°00'00" East for a distance of 12.16 feet to a point; thence run South 28°34'39" East for a distance of 356.16 feet to a point; thence run South 90°00'00" West for a distance of 335.49 feet to a point; thence run North 26°03'26" East for a distance of 348.16 feet to a point, said point being the Point of Beginning.




1. This Exhibit may be replaced by a land survey of the Premises once it is received by Licensee.






