

**CORPORATION FORM WARRANTY DEED**  
**JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP**

That, in consideration of \$ 160,800.00 to the undersigned Grantor,

acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto  
BUDDIE L. JONES, JR.  
(herein referred to as "Grantees") as joint tenants with rights of survivorship, the following described real  
estate, situated in Shelby County, Alabama, to-wit:
