FINAL ORDER

This order serves to resolve all claims and disputes in this litigation. First, as discussed in this Court's order of May 24, 2004, the following is hereby ORDERED:

1. JUDGMENT is hereby rendered in favor of Joseph Gillespie and against Gilco, Inc., L. Rod Hutchinson, and Gretchen Hutchinson, jointly and severally, in the total sum of \$6,335.62.

2. JUDGMENT is rendered in favor of Gilco Machine and Welding, Inc., and against Gilco, Inc., L. Rod Hutchinson, and Gretchen Hutchinson, jointly and severally, in the total sum of \$2,508,839.45.

3. JUDGMENT is rendered in favor of Joseph Gillespie and Gilco Machine and Welding, Inc., and against Gilco, Inc., and L. Rod Hutchinson, jointly and severally, in the amount of \$13,621.90 for damages to the real property at issue.

4. JUDGMENT is rendered in favor of Joseph Gillespie and Gilco Machine and Welding, Inc., on the claims asserted against them by Gretchen Hutchinson and Gilco, Inc. The claims of Gretchen Hutchinson and Gilco, Inc., against Joseph Gillespie and Gilco Machine and Welding, Inc. are DISMISSED with prejudice.

In addition, the pending summary judgment motion of the plaintiff, BancPartners Leasing, Inc., against defendants Gilco, Inc., and Rod Hutchinson is hereby GRANTED, there appearing no dispute of material fact and the plaintiff being entitled to judgment as a matter of law. Accordingly, the following is hereby entered:


1. JUDGMENT in the amount of \$67,039.39 is hereby entered in favor of the plaintiff, BancPartners Leasing, Inc., and against defendants Gilco, Inc., and Rod Hutchinson, jointly and severally.
