

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

**OF** 

#### GREYSTONE RESIDENTIAL ASSOCIATION, INC.

The undersigned, pursuant to *Ala. Code* § 10-3A-82 (1975), hereby adopt the following Articles of Amendment to the Articles of Incorporation of Greystone Residential Association, Inc. and certify as follows:

- 1. <u>Name of Corporation</u>. The name of the corporation is "Greystone Residential Association, Inc." (hereinafter referred to as the "<u>Association</u>").
- 2. <u>Amendment to Article 4</u>. Article 4 of the Articles of Incorporation of the Association is amended by deleting Article 4 in its entirety and by substituting in lieu thereof the following:
  - "4. INITIAL REGISTERED OFFICE AND AGENT. The location and mailing address of the registered office of the Association, and the name of its registered agent at such address are as follows:

Wallace, Jordan, Ratliff & Brandt, LLC 800 Shades Creek Parkway, Suite 400 Birmingham, Alabama 35209 Attention: Michael J. Brandt."

- 3. <u>Voting by Members</u>. Pursuant to Section 12 of the Articles of Incorporation of the Association, Daniel Oak Mountain Limited Partnership, an Alabama limited partnership ("<u>Developer</u>"), without the consent or approval of any of the members of the Association, has the sole and exclusive right to adopt amendments to the Articles of Incorporation of the Association. Attached hereto and incorporated herein by reference is a Consent of Developer to the foregoing amendment.
- 4. Adoption by Board of Directors. The Board of Directors of the Association has unanimously adopted the foregoing amendment at a meeting of the Board of Directors held on this date. Attached hereto and incorporated herein by reference is a copy of the Unanimous Written Consent of the Board of Directors approving the foregoing amendment.
