\$118,400.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.



**IN WITNESS WHEREOF**, the Grantor has signed and sealed this Deed on the 22<sup>nd</sup> day of June, 2004.


