

WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS, That in consideration of Ten and No/100 (\$10.00) Dollars to the undersigned Grantor in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, JUDY WATTS, a married woman, (herein referred to as Grantor) do grant, bargain, sell and convey unto JERRY W. MOORE and wife, REBECCA A. MOORE (herein referred to as Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Begin at the SW corner of the SW1 of the NE1, Section 34, Township 19 South, Range 2 East, and run thence North along the West line of said Forty a distance of 579 feet to the point of beginning of the lot herein conveyed; thence continue North along the West line of said Forty a distance of 210 feet to a point; thence run East a distance of 420 feet to a point; thence run South a distance of 210 feet to a point; thence run West a distance of 420 feet to the West line of said Forty and being the point of beginning. Said parcel of real estate being situated in the SW1 of the NE1, Section 34, Township 19 South, Range 2 East, Shelby County, Alabama and containing 2 acres, more or less.

Subject to all easements of record.

TO HAVE AND TO HOLD to the said Grantees for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And I do for myself and for my heirs, executors and administrators covenant with the said Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever against the lawful claims of all persons.
