EXHIBIT A LEGAL DESCRIPTION

Commence at the Southeast corner of the SE 1/4 of the NW 1/4 of Section 34, Township 24 North, Range 15 East, and thence run West along the South line of said 1/4-1/4 section, a distance of 133.84 feet; thence turn an angle of 90 degrees 00 minutes to the right and run North a distance of 70.56 feet to a point, being the SE corner of Aubrey May lot; thence turn an angle of 90 degrees 30 minutes to the left and run along the South line of said Aubrey May lot 100.00 feet to the SW corner of said May lot and the point of beginning; thence turn an angle of 90 degrees 30 minutes to the right and run along the West line of said May lot 178.30 feet; thence turn an angle of 98 degrees 42 minutes to the left and run a distance of 200.00 feet; thence turn an angle of 81 degrees 18 minutes to the left and run a distance of 200.00 feet; thence turn an angle of 98 degrees 42 minutes to the left and run a distance of 200.00 feet; thence turn an angle of 81 degrees 18 minutes to the left and run a distance of 21.70 feet to the point of beginning.
