

**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Alabama Business Corporation Act, as amended, hereby adopt the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is Green Friendly, Inc.

**ARTICLE II. DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III. PURPOSE**

The purpose for which the corporation is organized is to engage in the transaction of any or all lawful business for which the corporation may be incorporated under Section 10-2A-1 et seq. of the Code of Alabama.

**ARTICLE IV. CAPITAL STOCK**

The aggregate number of shares that the corporation has the authority to issue is One Thousand (1,000) of all which shall be common shares with par value of One Dollar (\$1.00) per share.

**ARTICLE V. LOCATION OF INITIAL REGISTERED OFFICE AND NAME OF INITIAL REGISTERED AGENT**


