## LIMITED POWER OF ATTORNEY

ALLEMINIS

This Limited Power of Attorney is executed as of August 2, 2000, by FIRST UNION NATIONAL BANK, a national banking association with its principal place of business in Charlotte, North Carolina, ("First Union") appointing as attorney-in-fact First Nationwide Mortgage Corporation with its principal place of business in Frederick, MD ("Servicer").

This limited power of attorney is not intended to extend the powers granted to Servicer under the Agreement or to allow Servicer to take any action with respect to a mortgage loan not authorized by the Agreement.

This Limited Power of Attorney shall be effective as of August 2, 2000 and shall continue in full force and effect until revoked by First Union in writing delivered to Servicer and filed of record in the real property records.
