

## CERTIFICATE OF RESTATEMENT OF THE ARTICLES OF INCORPORATION OF MEDICAL PRACTICE, INC.

THIS CERTIFICATE OF RESTATEMENT OF THE ARTICLES OF INCORPORATION is made and entered into as of August 4, 2004, by the members of the Board of Directors of Medical Practice, Inc., an Alabama corporation (the "Corporation").
