

## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Three Hundred Thirty-Four Thousand Five Hundred and NO/100 Dollars (\$334,500.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged DIAMOND HOMEBUILDERS, L.L.C., an Alabama limited liability company (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto JAMES E. BARNETT, JR. and LEIGH A. BARNETT, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, its interest in the following described real estate situated in Shelby County, Alabama, to wit:

Lot 223, according to the Survey of The Woodlands, Sector 2, 4 and 5, as recorded in Map Book 29, Page 99, in the Probate Office of Shelby County, Alabama.
