JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP

Connor, husband and wife**, in hand paid by the Grantees named herein, the receipt of which is hereby acknowledged, the said Grantor(s) does by these presents, grant, bargain, sell and convey unto **Geoffrey A. Hall and Deborah B. Hall** (herein referred to as "Grantees") the following described real estate, situated in Shelby County, Alabama, to-wit:
