## KNOW ALL PERSONS BY THESE PRESENTS:

That in consideration of Five Hundred and 00/100 Dollars (\$500.00) to the undersigned GRANTOR(S) in hand paid by the GRANTEE(S) herein, the receipt of which is hereby acknowledged, BARBARA H. ADKINS and FRANK W. ADKINS, husband and wife (herein referred to as GRANTOR)

(BARBARA H. ADKINS IS ONE AND THE SAME PERSON AS BARBARA HAMBY STONE, who is the record owner of the property described below through statutory warranty deed recorded in Book 187, Page 281, in the Probate Office of Shelby County, Alabama).

do hereby grant, bargain, sell and convey unto BARBARA H. ADKINS and FRANK W. ADKINS (herein referred to as GRANTEE(S)) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in SHELBY County, Alabama:
