

KNOW ALL MEN BY THESE PRESENTS, that in consideration of ONE HUNDRED AND NINETY THOUSAND AND NO/100.......(\$190,000.00) Dellars, to the undersigned grantor in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, I, ANNE S. SCOGIN, An Unmarried Woman (herein referred to as grantor), do grant, bargain, sell and convey unto WILLIAM T. DOBSON and STEPHANIE S. DOBSON (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in SHELBY County, Alabama to-wit:

Lot 6, in Block 5, according to a Resurvey, as recorded in Map Book 6, Page 97, in the Office of the Judge of Probate of Shelby County, Alabama, of Applecross, a subdivision of Inverness.

Subject to:
