GORDON and SILVIA M. GORDON, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto, STANTON L. KELLEY & KELLIE M. KELLEY, (herein referred to as "Grantees"), as joint tenants with rights of survivorship, their interest in the following described real estate situated in Shelby County, Alabama, to wit:

Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2004 and subsequent years not yet due and payable.


\$277,400.00 of the purchase price recited herein was paid from the proceeds of two mortgage loans closed simultaneously herewith.
