

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

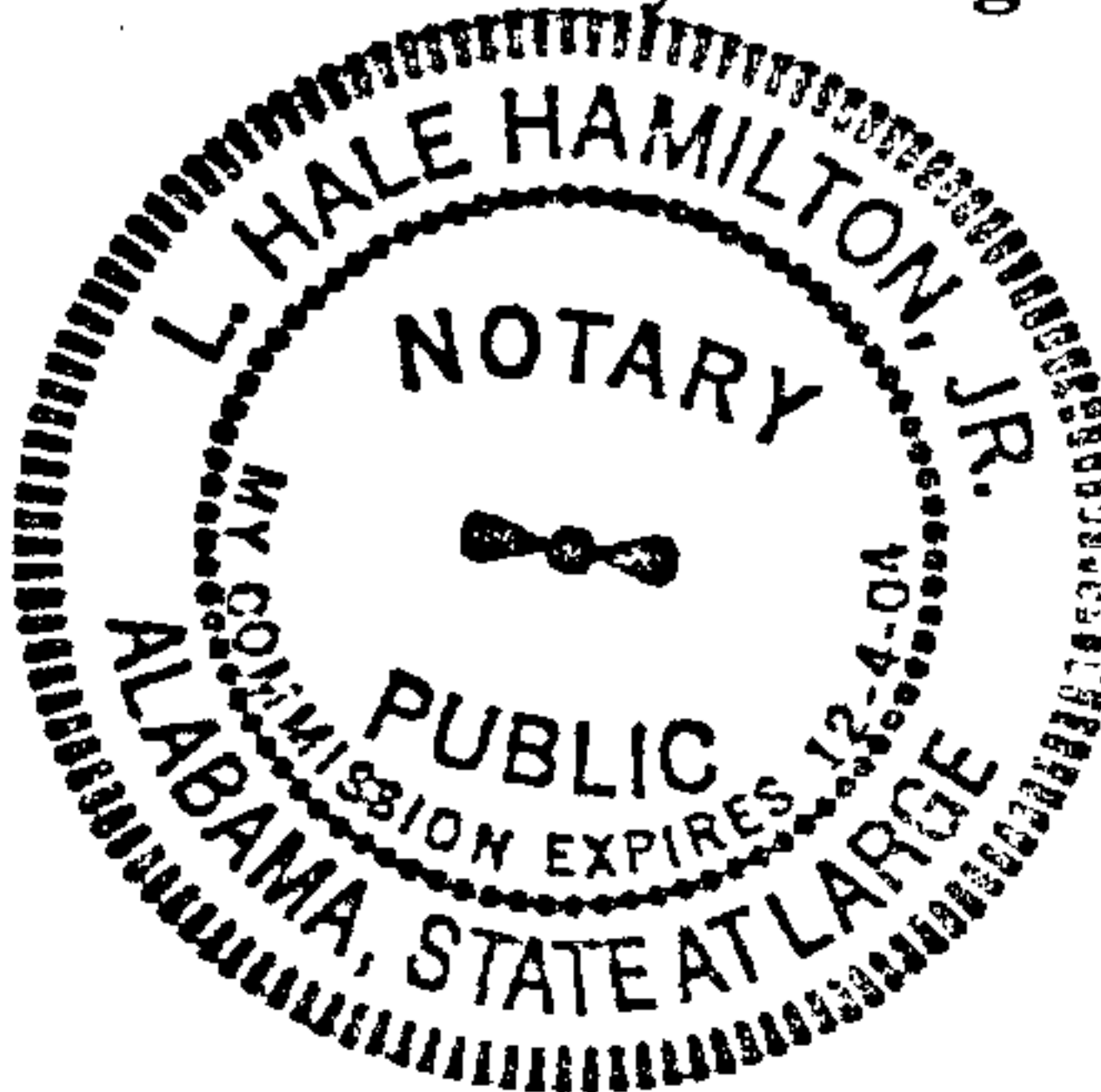


