

CORPORATION FORM WARRANTY DEED

Described property to become the homestead of the Grantees.

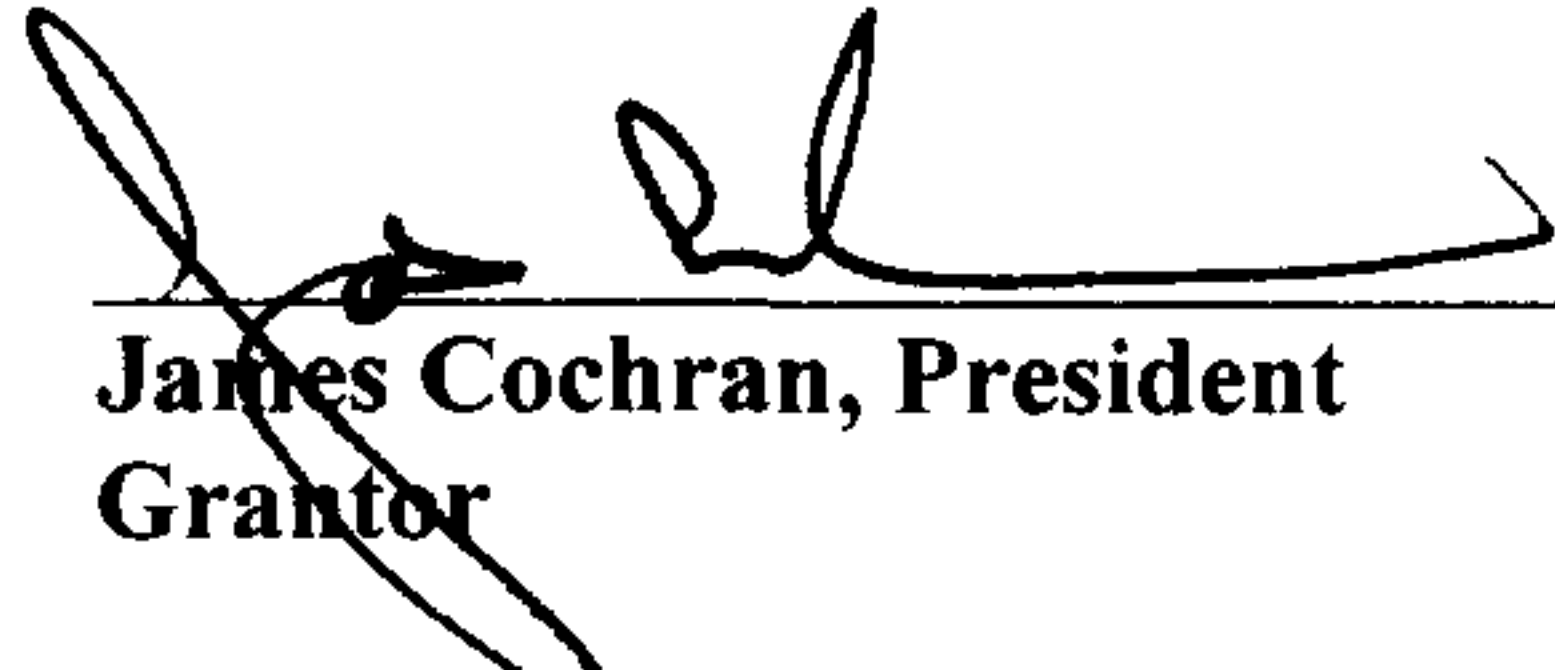

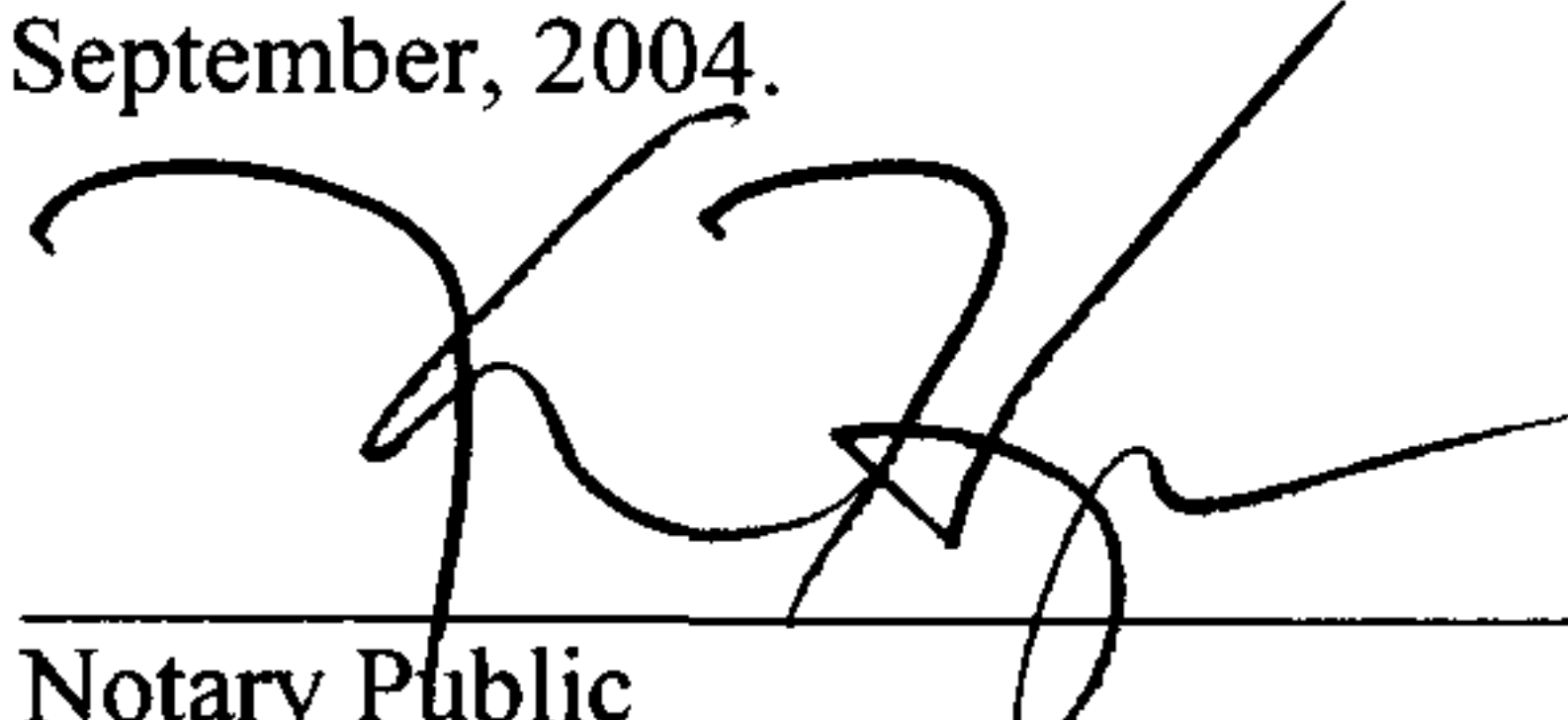
