Know All Men by These Presents: That in consideration of **Two hundred thirty two thousand four hundred and no/100 (\$232,400.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Crumpton Construction Company, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Timothy S. Liskey and Ann Marie Liskey** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
