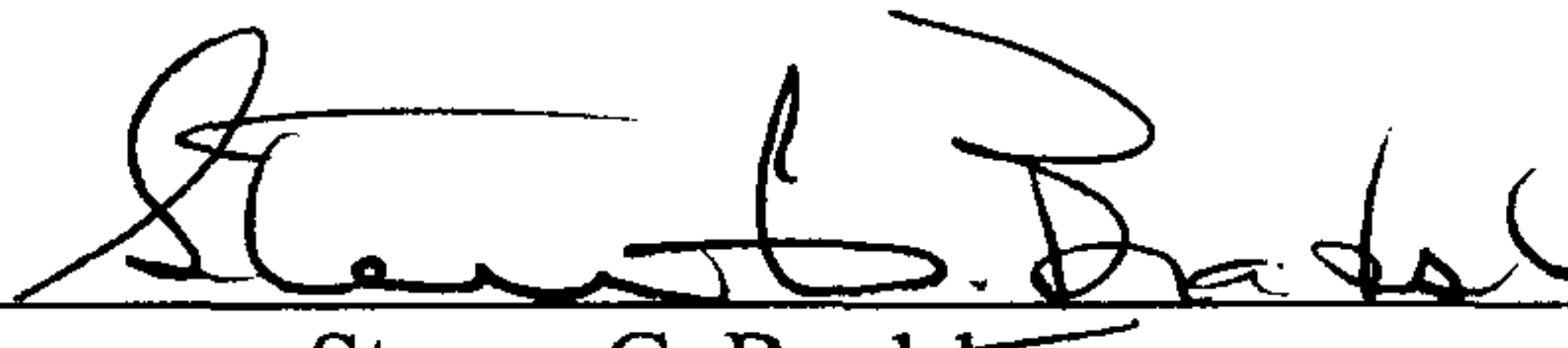

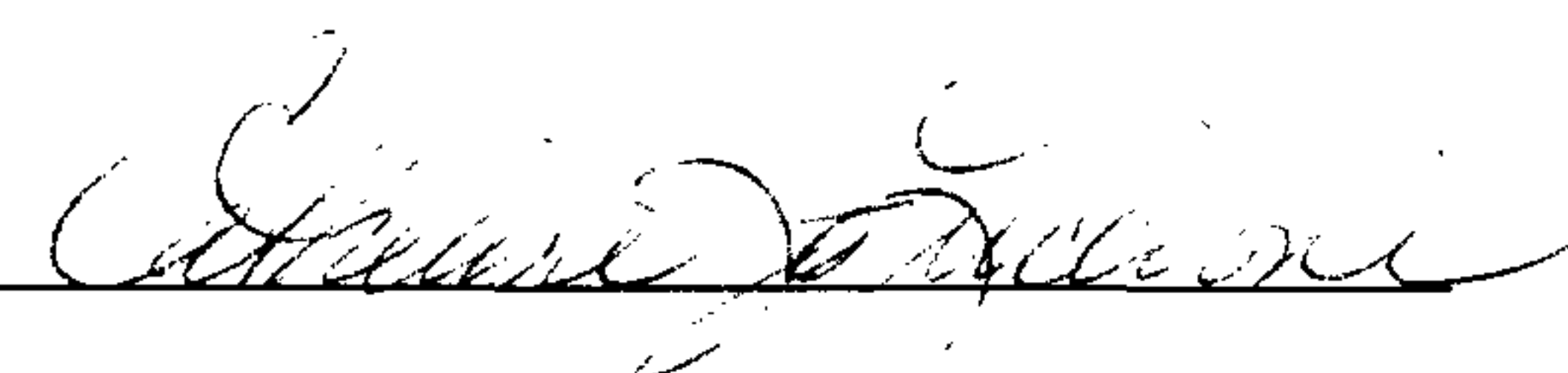

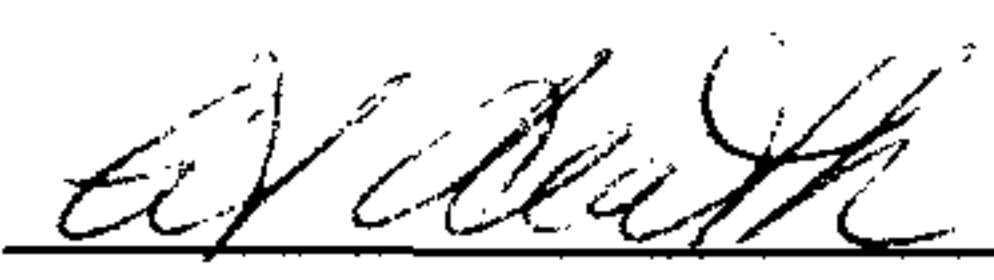

A PORTION OF LAND SITUATED IN THE NE 1/4 OF SECTION 28, TOWNSHIP 19 SOUTH, RANGE 2 WEST, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHEAST CORNER OF SECTION 28, TOWNSHIP 19 SOUTH, RANGE 2 WEST, SHELBY COUNTY, ALABAMA; THENCE RUN WEST ALONG THE NORTH LINE OF SAID SECTION A DISTANCE OF 2260 FEET; THENCE TURN LEFT AND RUN SOUTH 14 DEG. 10 MIN. EAST A DISTANCE OF 999.03 FEET; THENCE TURN LEFT 108 DEG. 55 MIN. 35 SEC AND RUN NORTHEASTERLY A DISTANCE OF 21.14 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE NORTHEASTERLY ALONG THE LAST DESCRIBED COURSE A DISTANCE OF 598.95 FEET; THENCE TURN LEFT 71 DEG. 04 MIN. 25 SEC. AND RUN NORTHWESTERLY A DISTANCE OF 243.0 FEET; THENCE TURN LEFT 112 DEG. 43 MIN. 25 SEC. AND RUN SOUTHWESTERLY A DISTANCE OF 614.25 FEET TO THE EASTERLY RIGHT OF WAY LINE OF VALLEY VIEW DRIVE; THENCE TURN LEFT 67 DEG. 16 MIN. 35 SEC.
