MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on April 11, 2003, **John Hunt, a married man, and Tina Hunt, a married woman, husband and wife, Party of the First Part**, executed a certain mortgage to **First Heritage Mortgage Company**, which said mortgage is recorded in Instrument No. 200304220000245880, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to JPMorgan Chase Bank As Trustee, c/o Residential Funding Corporation; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of JPMorgan Chase Bank as Trustee in the amount of **TWO HUNDRED FORTY-SIX THOUSAND FIVE HUNDRED TEN AND 00/100 DOLLARS (\$246,510.00)**; which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to JPMorgan Chase Bank as Trustee; and
