STATUTORY CORPORATION FORM WARRANTY DEED

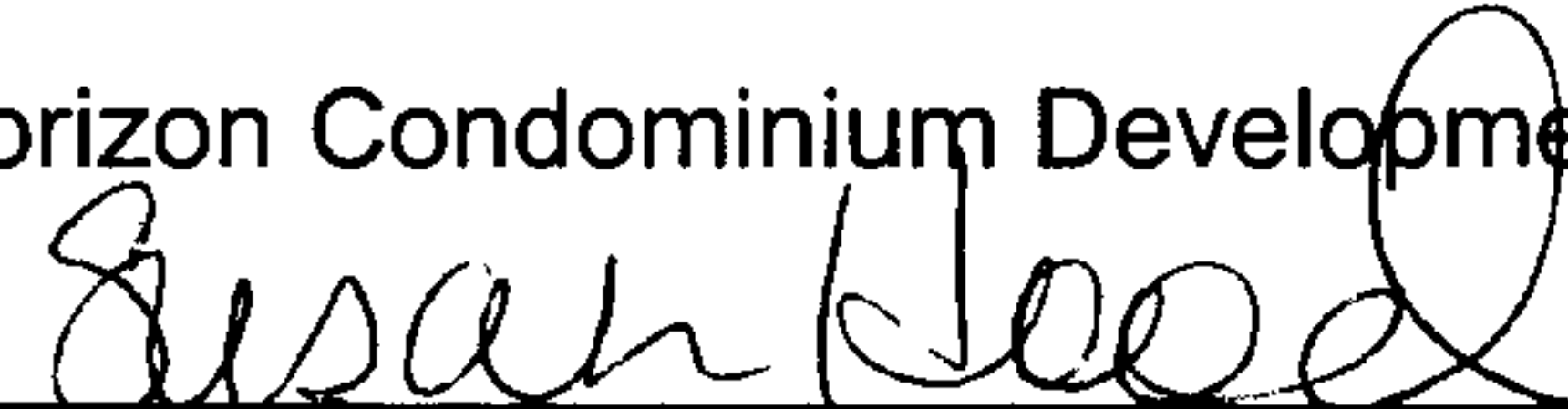
