KNOW ALL MEN BY THESE PRESENTS:

That in consideration of the sum of **One Hundred Seventy Seven Thousand Five Hundred and 00/100 Dollars (\$177,500.00)** to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, I/we,

(herein referred to as GRANTORS) do grant, bargain, sell and convey unto
