KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Four Hundred Seventy-Eight Thousand and 00/100 (\$478,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **DKM Enterprises, Inc., an Alabama corporation** (hereinafter referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEEES, **Michael T. Patton and Amanda T. Patton**, (hereinafter referred to as GRANTEEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 2403, according to the Survey of Highland Lakes, 24th Sector, an Eddleman Community, as recorded in Map Book 33, Page 34, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.




