CORPORATION WARRANTY DEED-Joint Tenants with rights of survivorship

THAT IN CONSIDERATION OF **Three Hundred Ninety Four Thousand Nine Hundred and no/100 Dollars (\$394,900.00)** to the undersigned grantor, **Infinity Designs, Inc.**, a corporation, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, the said
Infinity Designs, Inc.

does by the presents, grant, sell, bargain and convey unto the said
Patricia Hughes and Mike Hughes

(herein referred to as Grantee(s)) for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **Shelby COUNTY**, Alabama to wit:

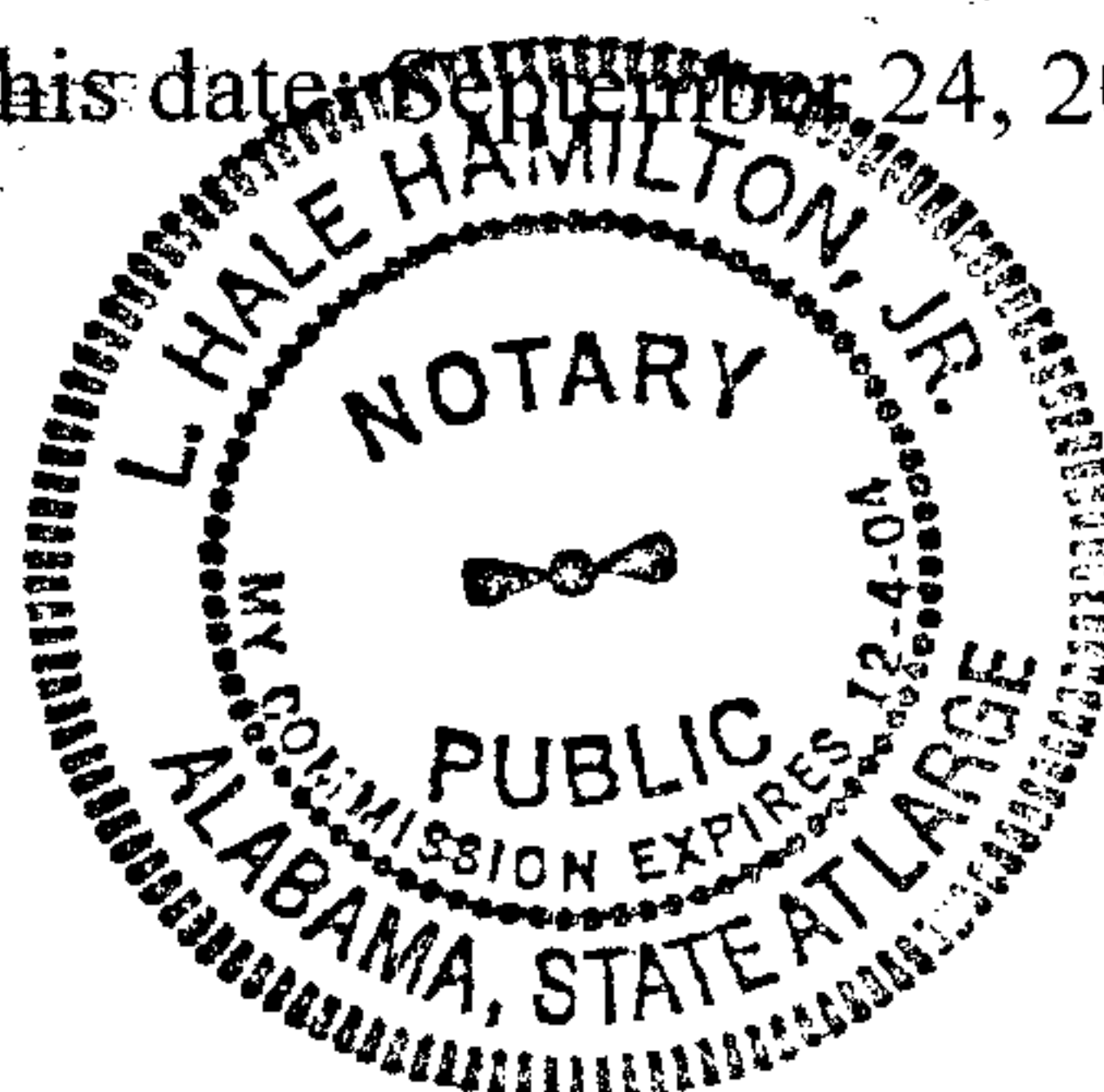

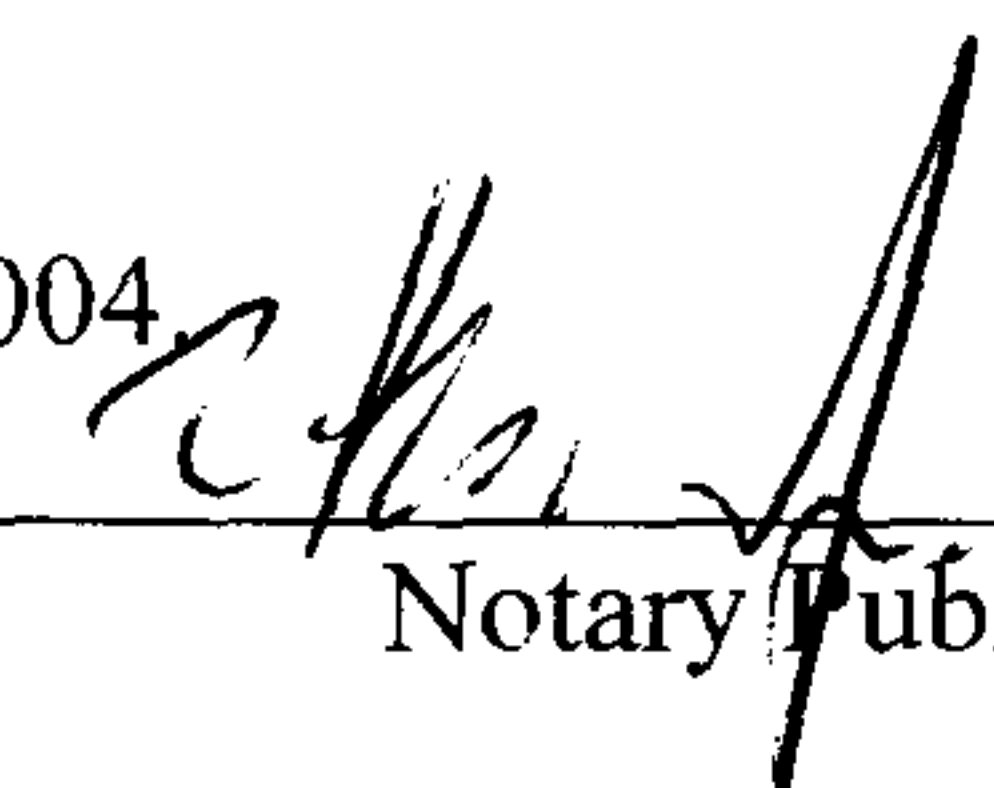
