

## RATIFICATION OF PLAT

This Ratification of Plat is hereby executed by **RANDY GOODWIN and DONNIE NORRIS**, this 4<sup>th</sup> day of October, 2004, and effective as of April 30, 2004.

### RECITALS

**WHEREAS**, as of April 30, 2004, Randy Goodwin ("Goodwin") and Donnie Norris ("Norris") were the record owners of certain acreage situated in Section 9, Township 21 South, Range 3 West located in Shelby County, Alabama, pursuant to deed recorded in Instrument 2002/6687 in the Probate Office of Shelby County, Alabama ("Goodwin Norris Acreage");

**WHEREAS**, on or about April 30, 2004, a portion of the Goodwin Norris Acreage was caused to be subdivided into a subdivision known as the **Survey of Lake Ridge** (the "Lake Ridge Property"), and a plat map thereof was partially executed and recorded in **Map Book 33, page 43** the Probate Office of Shelby County, Alabama, which map provided a signature line for Swift Creek Development, LLC as the owner (see Exhibit "A" attached hereto and made part hereof);






