FLEMMING, an unremarried widow (herein referred to as "Grantor"), does hereby grant, bargain, sell, and convey unto UNITED STATES STEEL CORPORATION, a Delaware corporation, successor (by conversion) to United States Steel LLC and remoter successor to USX Corporation (herein referred to as "Grantee"), the real estate being more particularly described on "EXHIBIT A" attached hereto and made a part hereof.

Said real estate does not constitute the homestead of Grantor.

LEGAL DESCRIPTION

The North one-half of the Southeast quarter of Section 4, Township 20 South, Range 3 West, Shelby County, Alabama being more particularly described as follows:

Begin at a 3" capped pipe marking the accepted location of the Northwest corner of the Northwest quarter of the Southeast quarter of Section 4, Township 20 South, Range 3 West, Shelby County, Alabama and run in an Easterly direction along the North line of said Northwest quarter of the Southeast quarter for 1312.37 feet to a 3" railroad rail; thence turn an interior angle of 180°02'35" and run to the left in an Easterly direction along the North line of the Northeast quarter of the Southeast quarter of said section for 1312.93 feet; thence turn an interior angle of 91°25'30" and run to the right in a Southerly direction along the East line of said Northeast quarter of the Southeast quarter for 1314.94 feet to a 3" capped pipe; thence turn an interior angle of 88°34'34" and run to the right in a Westerly direction along the South line of the Northeast quarter of the Southeast quarter of said section for 1309.73 feet to a 1-1/2"crimped pipe; thence continue along the last described course in a Westerly direction and along the South line of the Northwest quarter of the Southeast quarter of said section for 1309.95 feet to a 1/2" rebar; thence turn an interior angle of 91°40'04" and run to the right in a Northerly direction along the West line of the Northwest quarter of the Southeast quarter of said section for 1316.12 feet to the point-of-beginning, containing 79.16 acres, more or less.
