Merijanian, a married man**, herein referred to as grantor, **whether one or more**) grant, bargain, sell and convey unto, **David Michael and Susan Michael**, (herein referred to as grantee, **whether one or more**), the following described real estate, situated in Shelby County, Alabama, to-wit:
