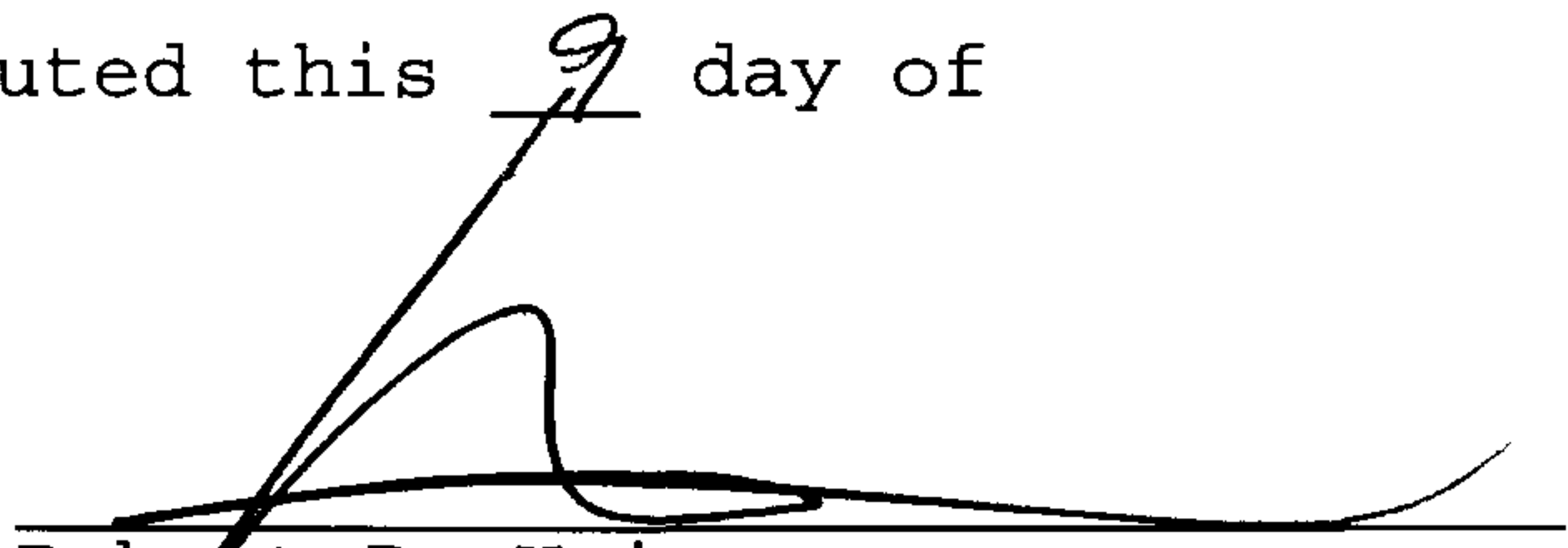
FULL SATISFACTION OF RECORDED LIEN

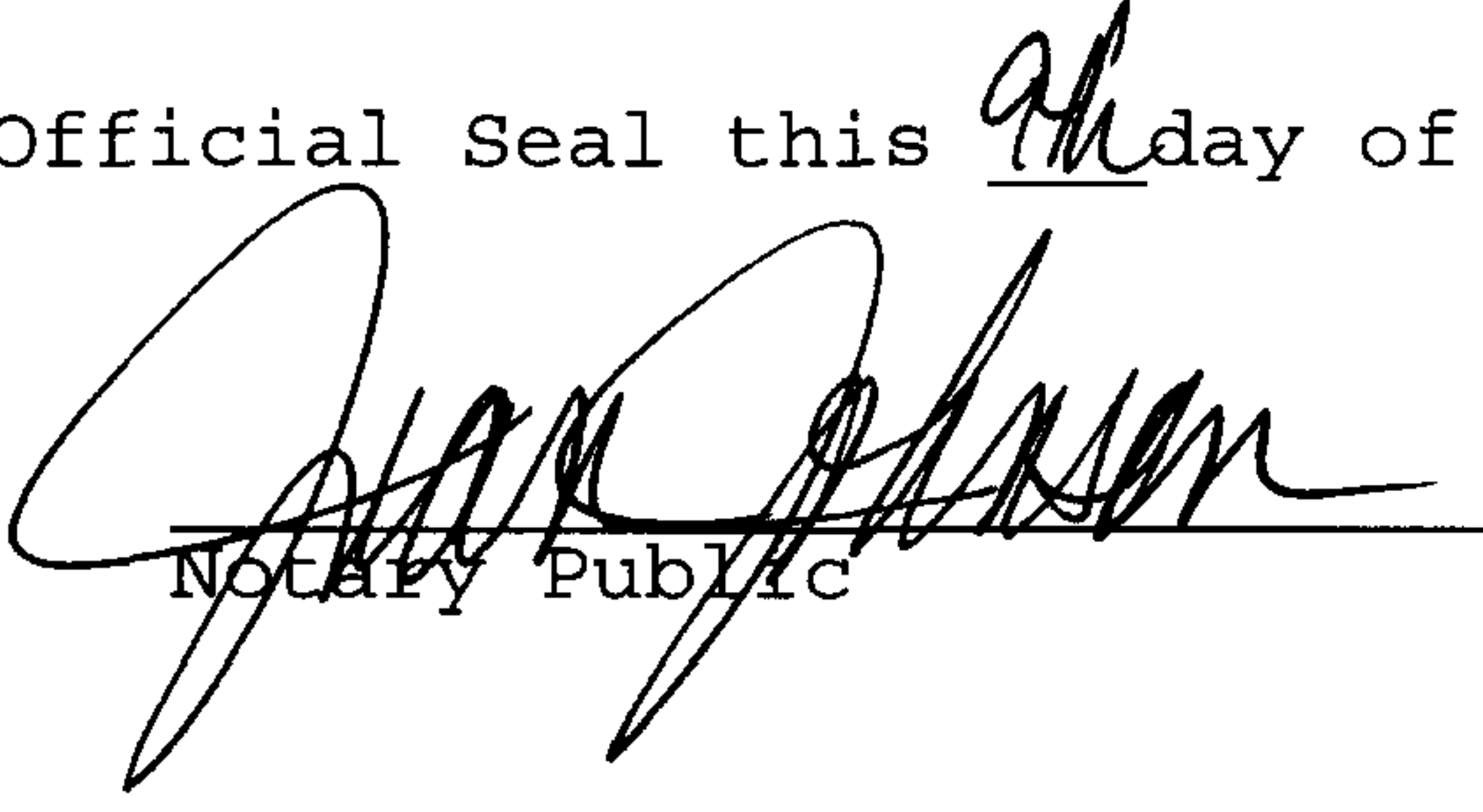

EXHIBIT A

A parcel of land situated in Southwest 1/4 of the Northwest 1/4 of Section 31, Township 19 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows:

Begin at the Northeast corner of said 1/4 - 1/4 and run North 88 deg. 09 min. 00 sec. West along the North line for a distance of 313.62 feet; thence run South 07 deg. 18 min. 19 sec. East for a distance of 75.66 feet; thence run South 58 deg. 06 min. 10 sec. West for a distance of 224.47 feet; thence run South 35 deg. 59 min. 19 sec. East for a distance of 549.19 feet; thence run South 59 deg. 03 min. 03 sec. West for a distance of 249.32 feet to a point on the easternmost right of way of U.S. Highway 31; thence run South 36 deg. 06 min. 02 sec. East along said right of way for a distance of 60.19 feet; thence leaving said right of way, run North 59 deg. 03 min. 24 sec. East for a distance of 249.37 feet; thence run South 36 deg. 02 min. 45 sec. East for a distance of 581.04 feet; thence run South 01 deg. 33 min. 01 sec. East for a distance of 172.64 feet to a point on the northernmost right of way of Allen/Winslett Road (possible prescriptive right of way); thence run South 55 deg. 07 min. 55 sec. East along said right of way for a distance of 129.96 feet; thence leaving said right of way, run North 45 deg. 30 min. 14 sec. East for a distance 222.88 feet to a point on the East line of said 1/4 - 1/4; thence run North 01 deg. 34 min. 39 sec. West along said East line for a distance of 102.87 feet; thence leaving said East line run North 88 deg. 41 min. 18 sec. West for a distance of 10.80 feet; thence run North 01 deg. 19 min. 31 sec. West for a distance of 1218.99 feet to a point on the North line of said 1/4 - 1/4; thence run North 88 deg. 09 min. 00 sec. West for a distance of 447.14 feet to the POINT OF BEGINNING. Said parcel being situated in Shelby County, Alabama.
