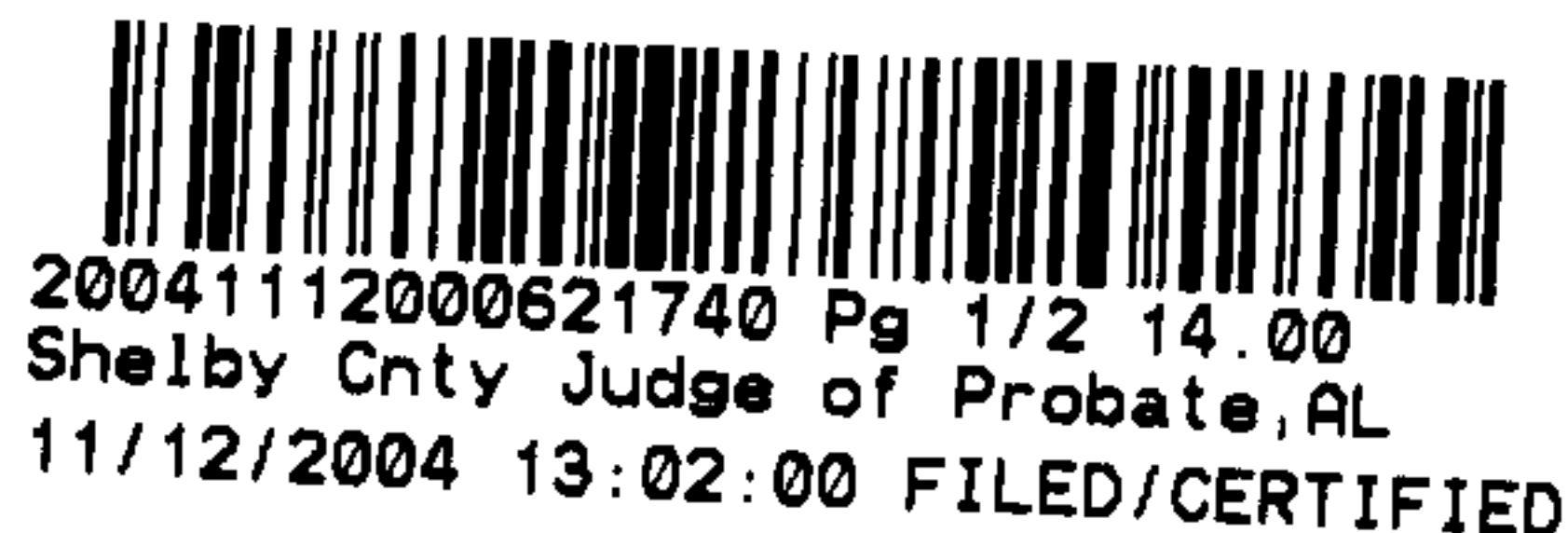

VERIFIED CLAIM OF LIEN
