MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 25, 2000, **Mark W. Wright and spouse, Peggy G. Wright, Party of the First Part**, executed a certain mortgage to **Sebring Capital Corporation**, which said mortgage is recorded in Instrument No. 2000-38989, in the Office of the Judge of Probate of Shelby County, Alabama which said Mortgage was last sold, assigned and transferred to Bank One, National Association, as Trustee; and

WHEREAS, on November 10, 2004, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Bank One, National Association, as Trustee in the amount of **ONE HUNDRED THIRTY THOUSAND FIFTY AND 00/100 DOLLARS (\$ 130,050.00)**; which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to Bank One, National Association, as Trustee; and


