

## MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 25, 2000, Mark W. Wright and spouse, Peggy G. Wright, Party of the First Part, executed a certain mortgage to Sebring Capital Corporation, which said mortgage is recorded in Instrument No. 2000-38989, in the Office of the Judge of Probate of Shelby County, Alabama which said Mortgage was last sold, assigned and transferred to Bank One, National Association, as Trustee; and
