KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Five Hundred Eighty-Nine Thousand Nine Hundred and 00/100 (\$589,900.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Sterling Companies, LLC, An Alabama Limited Liability Company by: Tynes Development Corporation**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Roderick O'Connor and Kymberli A. O'Connor**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 1829, according to the Survey of Highland Lakes, 18th Sector, Phase II, an Eddleman Community, as recorded in Map Book 30, Page 105, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.



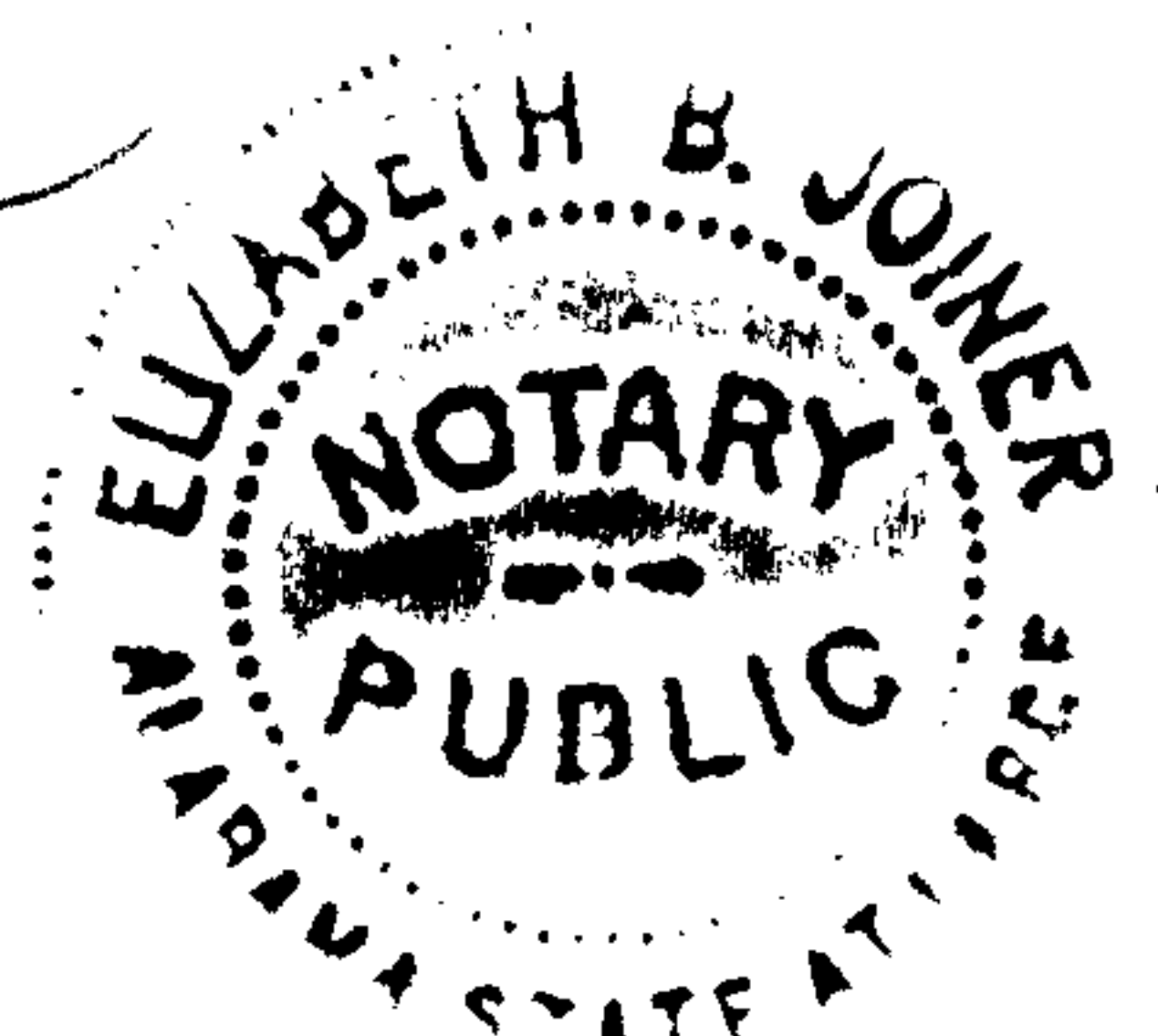
