PARTIAL SATISFACTION OF RECORDED LIEN

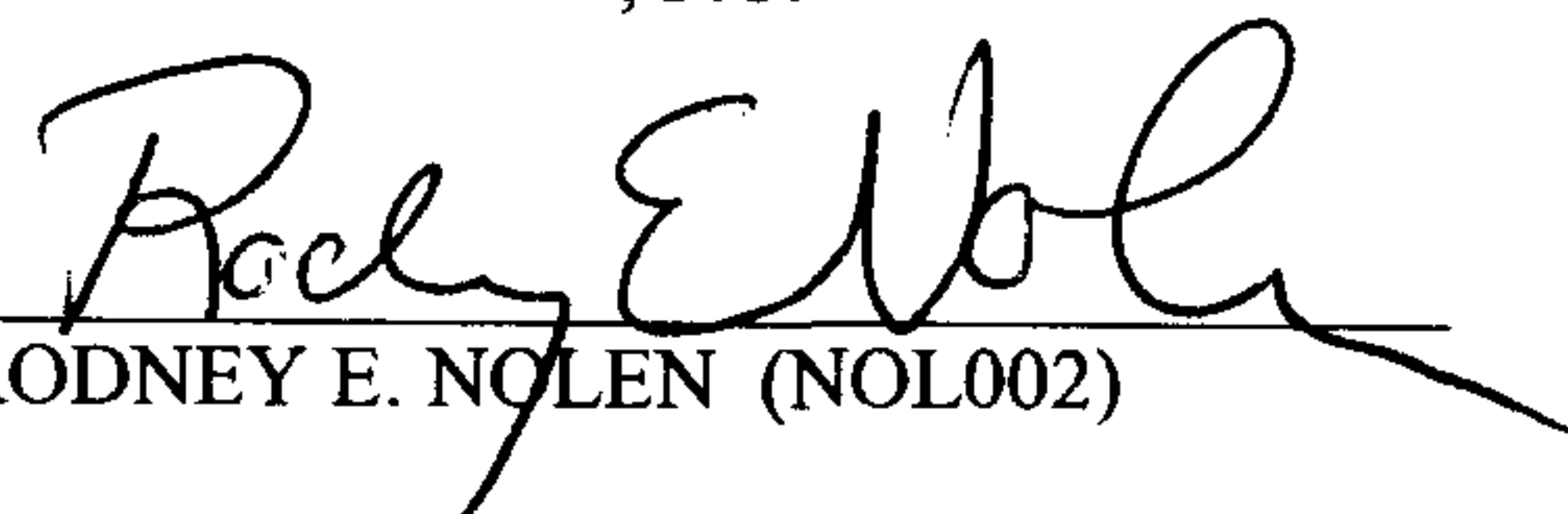

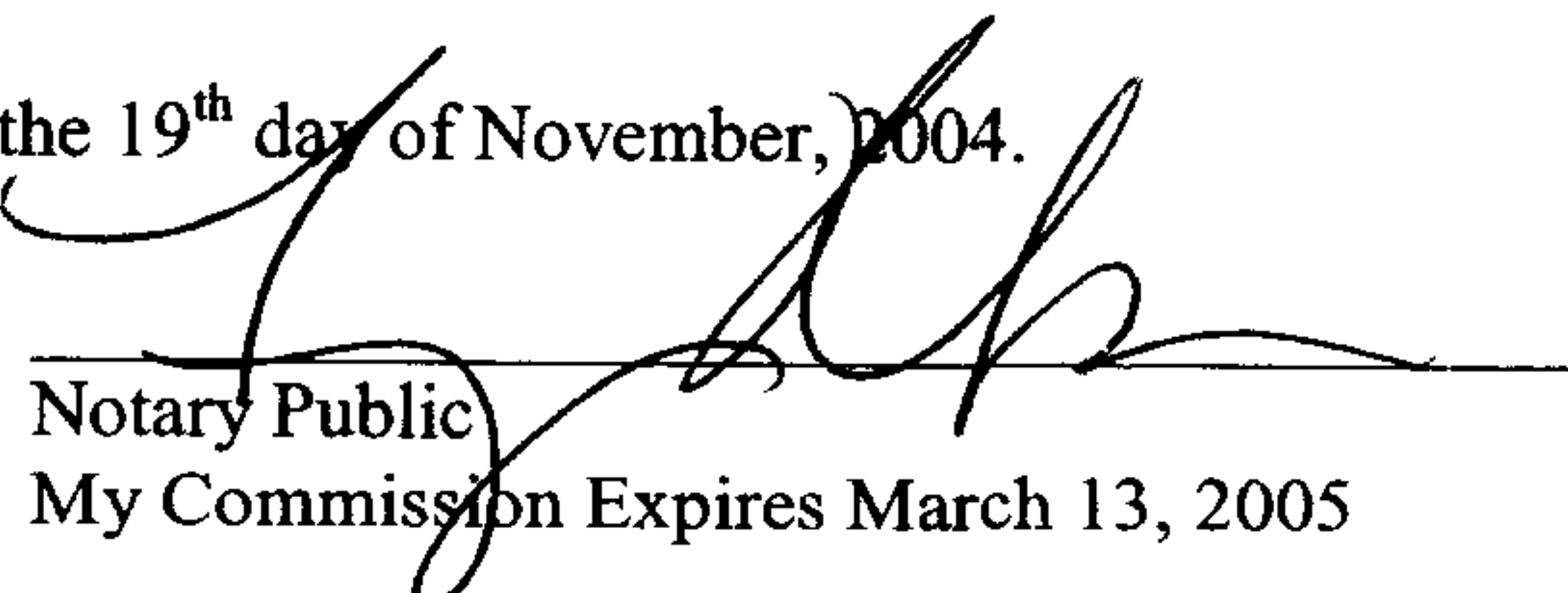
