Know All Men by These Presents: That in consideration of Fifty four thousand nine hundred and no/100 (\$54,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, GNC, LLC and W. McNeely, III, a married man (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto James Whittington and Karen Whittington (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:
