**WARRANTY DEED**  
**JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR**

STATE OF ALABAMA

SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS: That in consideration of One and no/100 (\$1.00) Dollar and other good and valuable consideration to the undersigned grantors, in hand paid by the grantees herein, the receipt whereof is acknowledged, I, **Tracy D. Hulsey, a single person** (herein referred to as grantor), do grant, bargain, sell and convey unto **Tracy D. Hulsey and Teresa McMaster** (herein referred to as grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

A parcel of land in the NE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 1, Township 21 South, Range 1 East, Shelby County, Alabama, described as follows: Commence at the Southeast corner of said  $\frac{1}{4}$ - $\frac{1}{4}$  section; thence run West along the South  $\frac{1}{4}$ - $\frac{1}{4}$  line 157.26 feet to the point of beginning; thence continue last course 147.5 feet; thence turn right 90°00' and run North 135.5 feet to the South right-of-way of a 40-foot public road; thence turn right 90°00' and run East 147.5 feet along said right-of-way; thence turn right 90°00' and run South 135.5 feet to the point of beginning.


This conveyance is made together with and subject to any and all easements, covenants, restrictions, reservations and rights of way appearing of recording and affecting the subject property.


