



## WARRANTY DEED JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

STATE OF ALABAMA
SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS: That in consideration of One and no/100 (\$1.00) Dollar and other good and valuable consideration to the undersigned grantors, in hand paid by the grantees herein, the receipt whereof is acknowledged, I, Tracy D. Hulsey, a single person (herein referred to as grantor), do grant, bargain, sell and convey unto Tracy D. Hulsey and Teresa McMaster (herein referred to as grantees), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

A parcel of land in the NE¼ of the SE¼ of Section 1, Township 21 South, Range 1 East, Shelby County, Alabama, described as follows: Commence at the Southeast comer of said ¼-¼ section; thence run West along the South ¼-¼ line 157.26 feet to the point of beginning; thence continue last course 147.5 feet; thence turn right 90°00' and run North 135.5 feet to the South right-of-way of a 40-foot public road; thence turn right 90°00' and run East 147.5 feet along said right-of-way; thence turn right 90°00' and run South 135.5 feet to the point of beginning.

This conveyance is made together with and subject to any and all easements, covenants, restrictions, reservations and rights of way appearing of recording and affecting the subject property.

TO HAVE AND TO HOLD to the said grantees for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

said grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that it is free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs and assigns forever, against the lawful claims of all persons.
