**ARTICLES OF ORGANIZATION  
OF  
EXECUTIVE REALTY TEAM, LLC**

**TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:**

Pursuant to the provisions of the Alabama Limited Liability Company Act (hereinafter referred to as "the Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

**ARTICLE I**

**NAME**

The name of the limited liability company ("Company") is **EXECUTIVE REALTY TEAM, LLC**:

**ARTICLE II**

**DURATION**

The period of duration for the Company shall be from the date of filing these Articles of Organization with the Office of the Judge of Shelby County, Alabama (the "Filing Date"), until the earliest to occur of the following:

- (1) The fiftieth (50th) anniversary of the Filing Date;

(2) Dissolution of the Company by the unanimous written agreement of the Members; or

(3) The occurrence of an event which under the Act constitutes an event of dissociation or otherwise works a termination of the Company under the Act, unless the legal existence and business of the Company are continued pursuant to Article VII below.

## **ARTICLE III**

### **PURPOSES**

The Company has been organized for the following purposes:

(1) The act as agents and assist in the purchase of real estate, purchase of residences and sale of real estate and residences;

(2) For any lawful purpose or purposes for which a limited liability company may be organized under the laws of the State of Alabama.

## **ARTICLE IV**

### **INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT**

The location and mailing address of the initial registered office of the Company is 5237 Highway 280 East Birmingham, Alabama 35242 and the name of the initial registered agent of the Company at such address is Carol Rindone.

## **ARTICLE IX**

### **MANAGEMENT**


