Legal Description of Property

The land referred to in this Commitment is described as follows:

A parcel of land located in the South 1/2 of the NE 1/4 of the NW 1/4 of Section 13, Township 20 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

Commence at the Northeast corner of the South 1/2 of the NE 1/4 of the NE 1/4 of the NW 1/4 of said Section 13; thence South 2 degrees 68 minutes 11 seconds West 583.58 feet to the POINT OF BEGINNING;; thence South 32 degrees 31 minutes 16 seconds West 218.67 feet; thence South 88 degrees 07 minutes 47 seconds East 211.36 feet to the Northwesterly right of way of Canyon Park Drive; thence North 19 degrees 08 minutes 18 seconds West leaving said right of way 198.75 feet to the POINT OF BEGINNING.

Also an easement for ingress and egress and utilities described as follows:

Commence at the Northeast corner of the South 1/2 of the NE 1/4 of the NW 1/4 of said Section 13; thence North 82 degrees 58 minutes 11 seconds West 612.32 feet; thence South 32 degrees 31 minutes 16 seconds West 218.87 feet to the POINT OF BEGINNING OF said easement; thence continue South 32 degrees 31 minutes 16 seconds West 170.93 feet; thence South 14 degrees 26 minutes 10 seconds West 52.57 feet to the Northwesterly right of way of Canyon Park Drive; thence North 59 degrees 15 minutes 04 seconds East along said right of way 124.08 feet; thence North 30 degrees 44 minutes 56 seconds West leaving said right of way 14.96 feet; thence North 21 degrees 10 minutes 33 seconds East 72.36 feet; thence North 80 degrees 34 minutes 45 seconds East 97.37 feet; thence North 88 degrees 07 minutes 47 seconds West 105.00 feet to the POINT OF BEGINNING.
