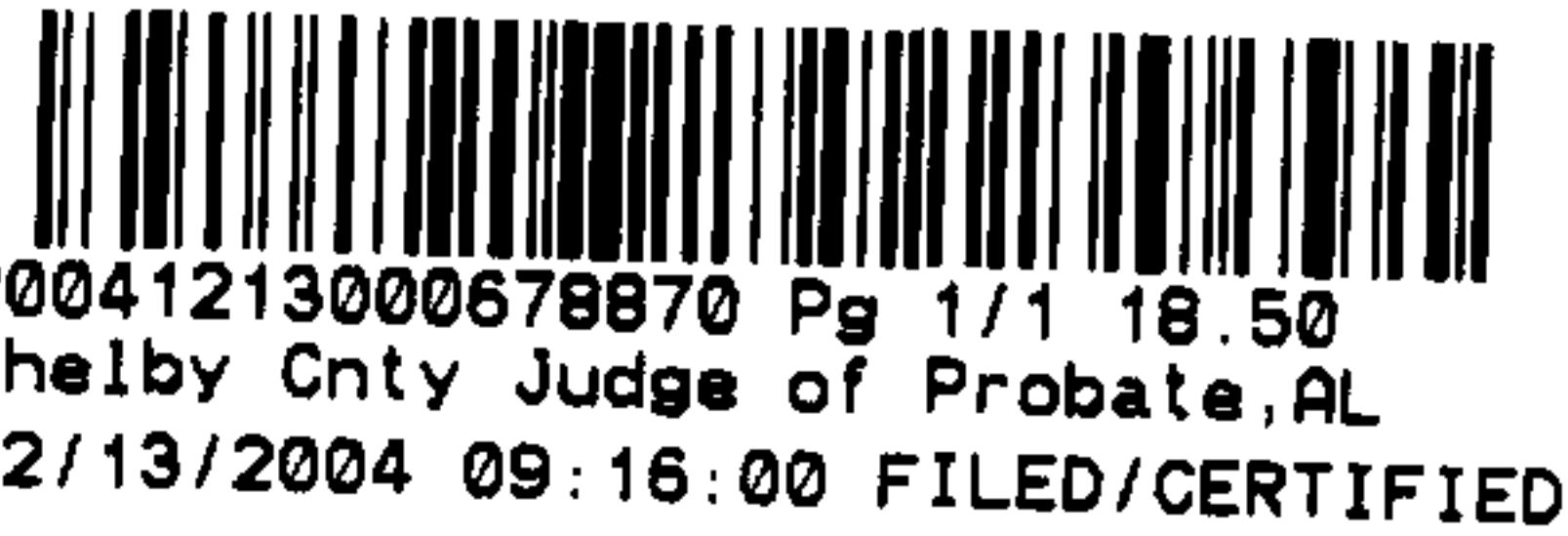

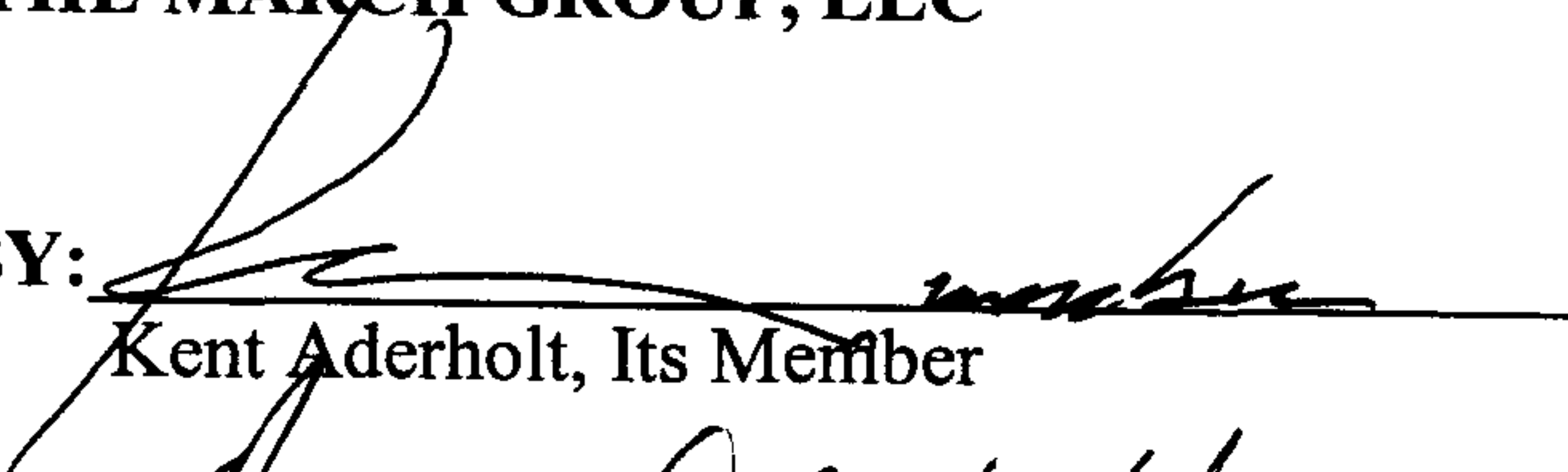
\$232,703.00 of the above recited purchase price was paid by a mortgage recorded simultaneously herewith.

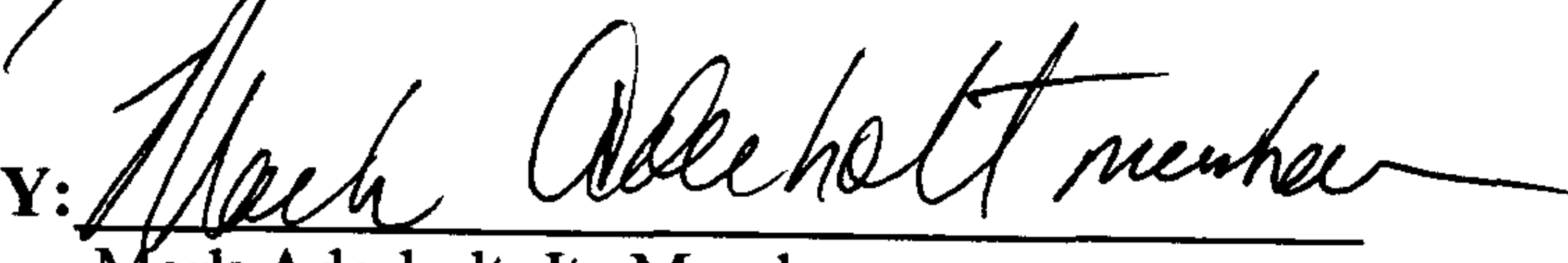
Subject to taxes for 2005 and subsequent years, easements, restrictions, rights of way and permits of record.

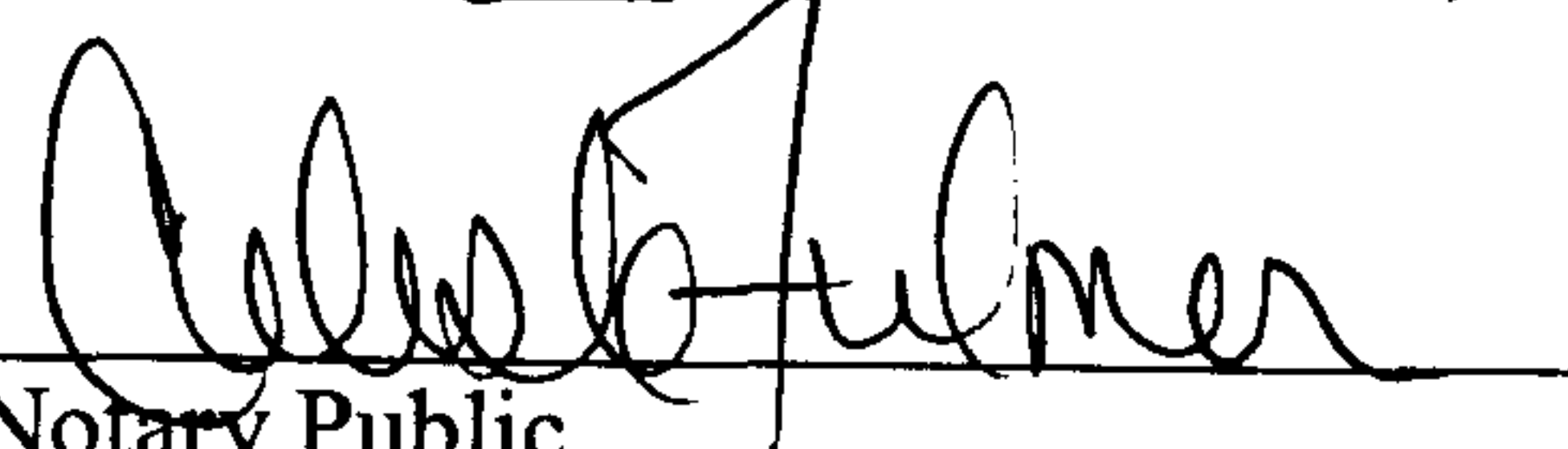
