PURSUANT TO THE PROVISIONS OF THE ALABAMA BUSINESS CORPORATION ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

**ARTICLE I:** The name of the corporation shall be: **REVOLUTION PERFORMANCE MARINE, INC.**

**ARTICLE II:** The duration of the corporation shall be perpetual unless otherwise stated.

**ARTICLE III:** The corporation has been organized for the purpose of engaging in the manufacturing and construction of boats including, but not limited to, the production, sale and distribution of boats.
