JOINT SURVIVORSHIP DEED**

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Three Hundred Nineteen Thousand Eight Hundred Sixty-Five and 00/100 (\$319,865.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Tom Lacey Construction Co, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Omeria Ann Davis and Jerome W. Davis, wife and husband**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 19, according to the Final Plat of Wild Timber, Phase 2, as recorded in Map Book 33 page 9 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

\$255,850.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

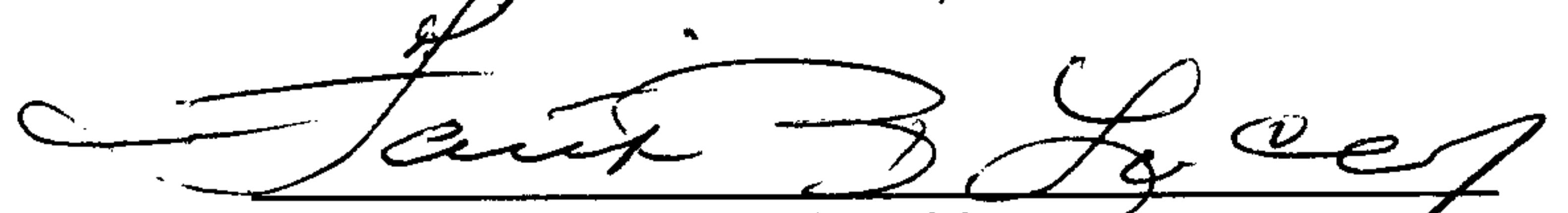
Tom Lacey Construction Co. Inc. and Tom Lacey Construction Company, Inc are one and the same entity.

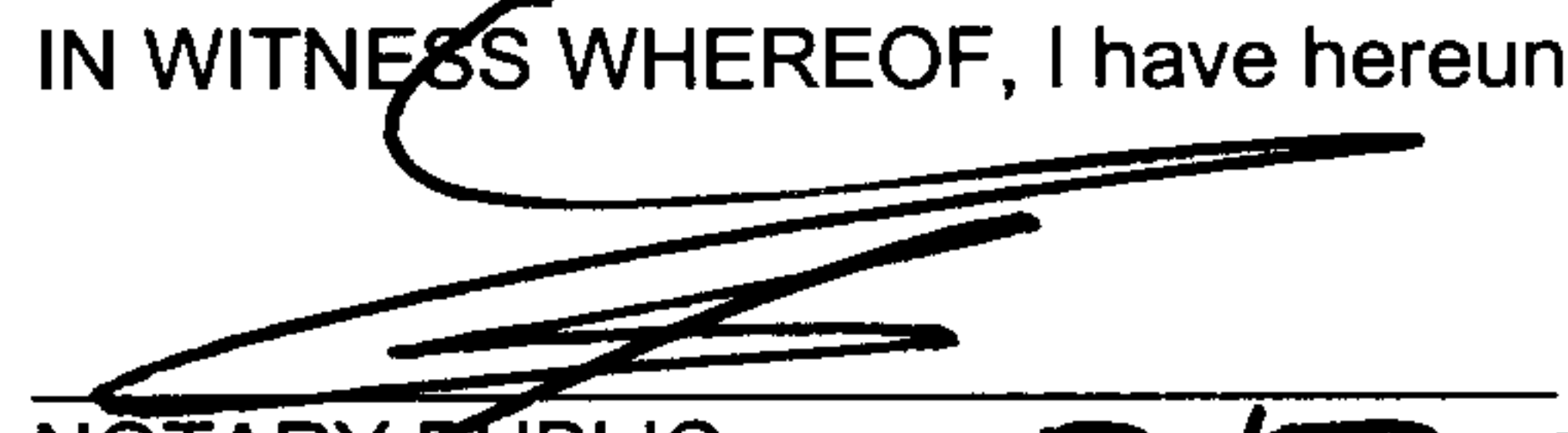
