FOURTH: No plan of distribution was adopted by the Corporation.



SIXTH: There are no suits pending against the Corporation in any court.


The dissolution of the Corporation is to be effective upon the filing of these Articles of Dissolution with the Office of the Judge of Probate of Shelby County, Alabama.
