ARTICLES OF ORGANIZATION

Pursuant to the provisions of the *Alabama Limited Liability Company Act*, §10-12-1 et. seq., *Code of Alabama* (1975), as amended, the undersigned hereby adopts the following Articles of Organization:

ARTICLE I

The name of the Limited Liability Company shall be: **BUILDING STARZ, LLC.**

ARTICLE II

The period of duration shall be: **Perpetual from and after the date of the formation of the Limited Liability Company unless the Limited Liability Company is earlier dissolved in accordance with either the provisions of the operating agreement or of the Alabama Limited Liability Company Act.**


