Know All Men by These Presents: That in consideration of **Fifty nine thousand nine hundred and no/100 (\$59,900.00)** to the undersigned grantors, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **GNC, LLC and W. McNeely, III, a married man** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **George Haney and Beverly Haney** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Mineral and mining rights excepted


This property does not constitute the homestead of W. A. McNeely, III nor his spouse.


