ARTICLES OF INCORPORATION OF Intentional Steps, Inc.

The undersigned, acting as Incorporator of a corporation under the *Code of Alabama* (1975), adopts the following Articles of Incorporation for such corporation:

- (1) NAME OF CORPORATION and DURATION: The name of the corporation shall be Intentional Steps, Inc., and the period of its duration shall be perpetual.
 - (2) PURPOSE: The objects and purposes for which the corporation is formed are:
- (a) To promote health among clients' employees through education and awareness programs focusing on disease prevention and heath promotion; to seek funds for health promotion activities and the establishment of a national speakers bureau from various sources, including grants, contracts, and business operations;

- (c) In furtherance and not in limitation of the aforesaid objects, to carry on any lawful business, to sell all types of goods and perform all types of services, and to do anything convenient in connection with the carrying on of such business; and to operate without any restrictions any legal business in the State of Alabama, or any other state of the United States, and to own, buy and sell personal property and to borrow money and issue bonds, notes or mortgages therefor.
- (3) INITIAL REGISTERED OFFICE: The address of the initial registered office of the corporation is 956 Tulip Poplar Lane, Hoover, Alabama 35244 and the name of its initial registered agent at such address is Valerie Padd.
- (4) STOCK: The amount of the total authorized capital stock of this corporation is fixed at \$1,000.00, divided into 1,000 shares of common stock of the par value of \$1.00 per share. The
