WARRANTY DEED

Know All Men by These Presents: That in consideration of **THREE HUNDRED NINETEEN THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$319,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **LOWERY HOMES, INC.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **TONY B. WILLIAMS AND TAJUANA G. WILLIAMS** (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 422 according to the survey of final Plat of Stoneykirk at Ballantrae, Phase 1, as recorded in Map Book 32 Page 11 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

SUBJECT TO easements, reservations, restrictions and covenants, set back lines and rights of way, if any, of record.

\$287,910.00 of the consideration recited herein is from the proceeds of a purchase money mortgage.
