## Articles of Amendment of Erwin Brothers, LLC Enacted January 6, 2005

The undersigned, acting pursuant to 10-11-12 of the Alabama Limited Liability Company Act, as last amended, hereby adopt the following Articles of Amendment:

FIRST: The name of the Limited Liability Company is: Erwin Brothers, LLC.

SECOND: The date of filing of the Articles of Organization: March 3, 2002.

THIRD: The following amendment was adopted in the manner provided for by the Alabama Limited Liability Act.

Two additional members will be admitted as members of the Limited Liability Company, with both of these two additional members owning 15% (fifteen) of the Limited Liability Company each, respectively. The names and addresses of the additional members of the Limited Liability Company are:
