Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

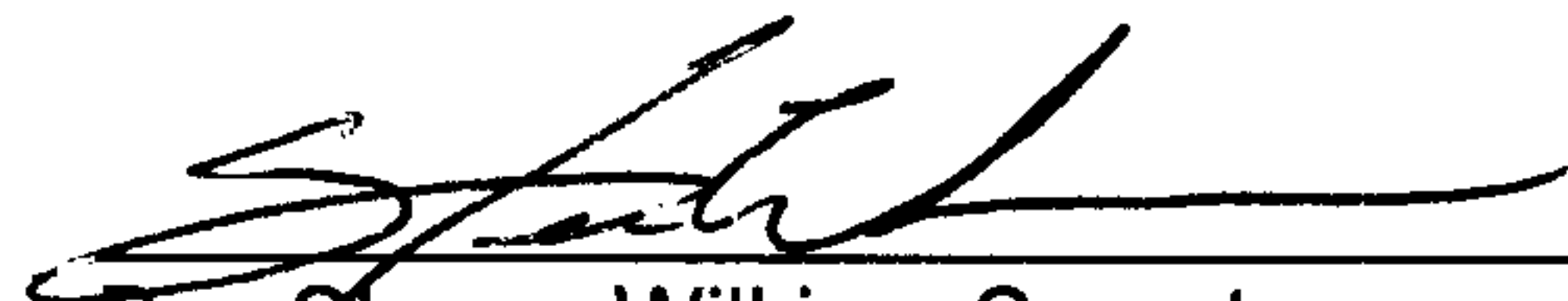
\$115,400.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith. This was a purchase money mortgage.

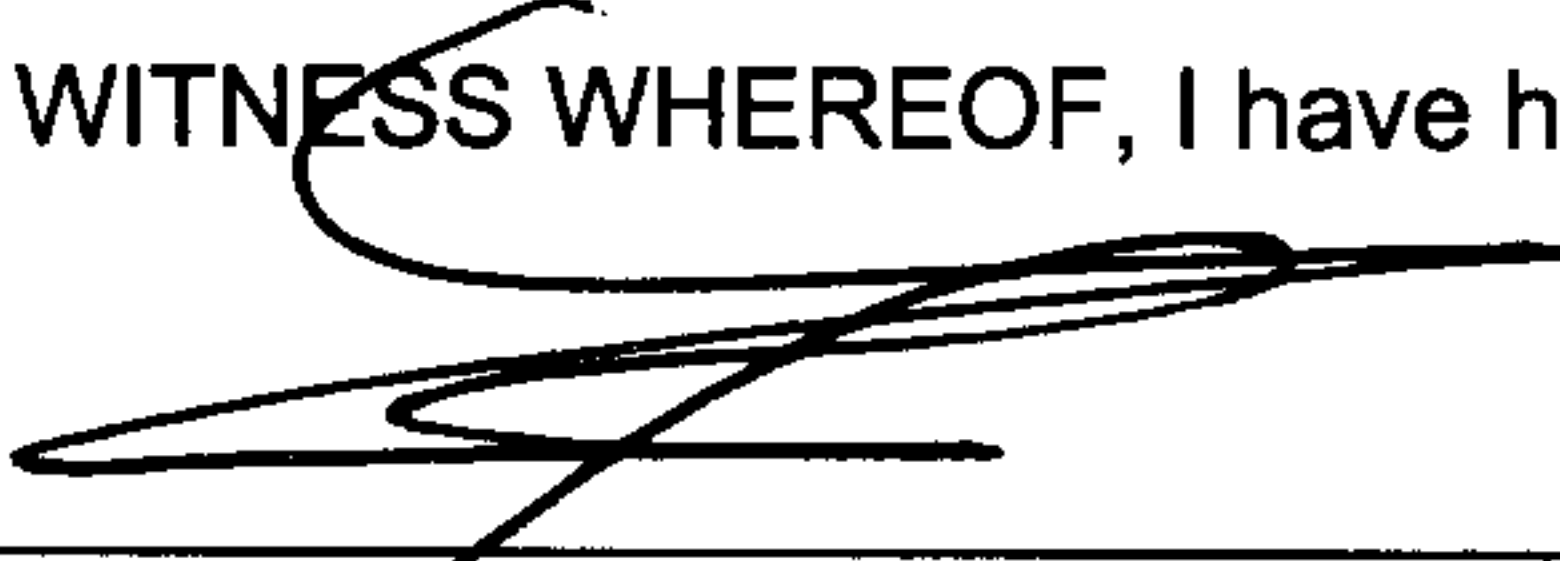

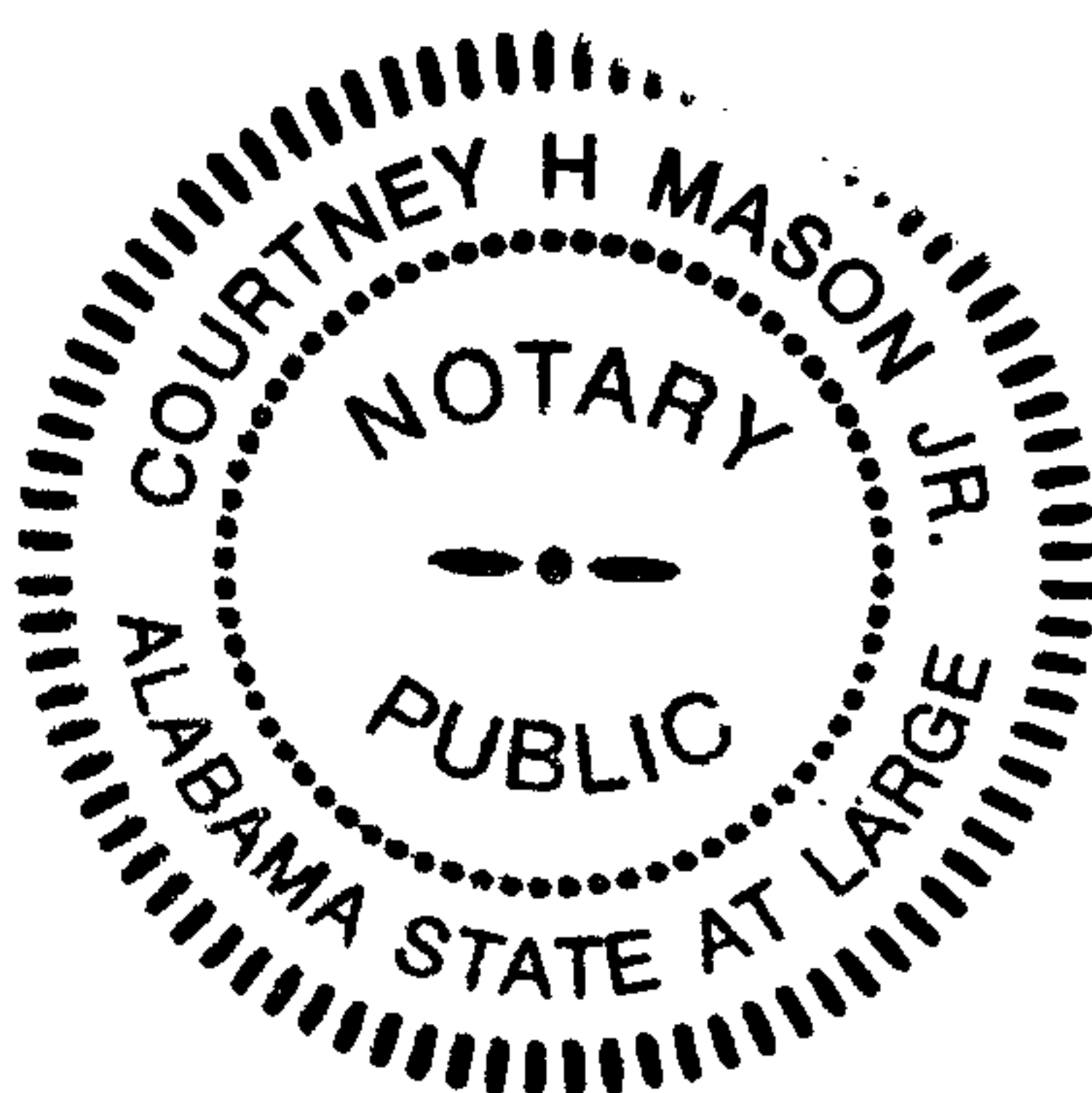
