## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

STATE OF ALABAMA SHELBY COUNTY

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One and no/100 (\$1.00) DOLLAR and Love and Affection to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, we John T. Lyon and wife, Shirley Ann Lyon (herein referred to as grantors) do grant, bargain, sell and convey unto John T. Lyon, Shirley Ann Lyon and Stephanie Anne Lyon (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Property described on Exhibit "A" attached hereto and made part and parcel hereof as fully as if set out herein.

Grantors, John T. Lyon and Shirley Ann Lyon, retain a life estate in and to the above described property so long as either of said grantors shall live, including but not being limited to all rights of possession and use of the property, the sale and conveyance of timber, crops, occupation of any buildings thereon, and any and all other rights of possession. Said life estate and/or rights of possession in favor of John T. Lyon and Shirley Ann Lyon shall expire only upon the death of the last survivor of said grantors.
